

CentralReach's K-12 Special Education Teacher Appreciation Contest Rules

1. **GRAND PRIZE DETAILS:** Five (5) separate grand prizes will be awarded. The grand prize includes five (5) Donors Choose donations to five (5) different K-12 Special Education teachers of students with disabilities nominated during the Contest Period (as defined below). Each grand prize winner will be eligible to receive up to \$200 value per Donors Choose donation.
2. **ELIGIBILITY:** To be eligible to win this contest, nominees must meet all the following conditions. Nominees must be a K-12 Special Education teacher or K-12 teacher of students with disabilities, must have a Donors Choose account in their name, the Donors Choose account must be set up during or before the Contest Period ends on May 12, 2023. In addition, all nominations must meet the Submission Guidelines below.
3. **CONTEST PERIOD:** The contest submissions period runs from May 1, 2023 at 8:00AM EST, to May 12, 2023 at 5:00PM EST ("Contest Period").
4. **RESTRICTIONS:** CentralReach and CentralReach Partners and their respective subsidiaries, affiliates, and advertising agencies and their employees and members of their immediate family (spouse, parent, sibling or child and their respective spouses, regardless of where they reside) and persons living in the same household of such employees, whether or not related, are not eligible to enter or win.
5. **SUBMISSION GUIDELINES:**
 - A nomination form must be completed during the Contest Period and must include all required information;
 - Nominees must meet the eligibility criteria herein; and
 - Your nomination must not: (i) violate any third-party rights, including copyrights, trademark rights, or rights of privacy and publicity; (ii) contain disparaging or defamatory statements; (iii) include threats to any person, place, business, or group; (iv) be obscene, offensive, or indecent; (v) depict any risky behavior; (vi) contain material that promotes bigotry, racism, hatred, disrespect, or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age; (vii) contain unauthorized third-party trademarks or logos or (viii) violate any law.
6. **SELECTION AND NOTIFICATION OF WINNERS.** Winners will be chosen at random based on nominations/entries from the official entry form that meet the criteria of these Contest Terms. Winners will be selected within **5** days of the end of the Contest Period. Winners will be contacted via email, phone, or directly through their Donors Choose account. Winners have 24 hours to respond and claim their prize or new winners will be chosen. Winners may be asked to sign a consent form for use of the winner's name, image and likeness as part of claiming a prize. A POTENTIAL WINNER IS SUBJECT TO VERIFICATION BY CENTRALREACH, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
